FIRE FLOW TEST REQUEST PROCEDURE

At this time, Western is only completing Fire Flow Model Requests. Only on a case by case basis will a request for a fire flow test or witness to a fire flow test be reviewed. Please see instructions below for these requests:

Riverside Retail Area and Murrieta Service Area

1. CUSTOMER completes the “Fire Flow Test Request Form” and returns it to Western’s Meridian office located at 14205 Meridian Parkway, Riverside, during the hours of 8:00 a.m. - 5:00 p.m. Monday-Friday, along with a payment in the amount of \$500.00 made payable to WMWD. The fee includes:
 - a. WMWD consultant to perform the fire flow model and provide results
 - b. Fire Flow Model Letter
 - c. Mapping
2. WMWD Development Services staff forwards the Fire Flow Model Work Request to Western’s consultant to complete the fire flow model.
3. After the model is complete WMWD consultant will forward results back to Development Services staff to prepare fire flow model letter.
4. CUSTOMER to specify if they will pick up the letter or have it mailed to them.

WMWD to Witness Fire Flow Test and Provide Letter

1. CUSTOMER completes the “Fire Flow Test Request Form” and returns it to Western’s Meridian office located at 14205 Meridian Parkway, Riverside, during the hours of 8:00 a.m. - 5:00 p.m. Monday-Friday, along with a payment in the amount of \$350.00 made payable to WMWD. The fee includes:
 - a. WMWD Operations staff to perform the test and provide results
 - b. Fire Flow Test Letter
 - c. Mapping
2. WMWD Development Services staff forwards the Fire Flow Test Work Request to Western’s El Sobrante or Murrieta location for coordination and authorization.
3. After the test is performed WMWD Operations staff will forward results back to Development Services staff to prepare fire flow test letter.
4. CUSTOMER to specify if they will pick up the letter or have it mailed to them.

WMWD to Witness Fire Flow Test and Provide Letter

Customer may hire their own fire flow testing company to perform this procedure. However, Western must still witness the test and collect the test paperwork. The fee is \$200.00 for Western to witness the test.

1. CUSTOMER completes the "Fire Flow Test Request Form" and returns it to Western's Meridian office located at 14205 Meridian Pkwy., Riverside, during the hours of 8:00 a.m. – 5:00 p.m. Mon.-Fri., along with a payment in the amount of \$200.00, made payable to WMWD. The fee includes:
 - a. WMWD Operations staff to witness the test and receive results
 - b. Fire Flow Test Letter
 - c. Mapping
2. CUSTOMER to determine what company will perform the fire flow test (a list of Fire Flow Testers is available) and provides the information to Western.
3. WMWD Development Services staff forwards the Fire Flow Test Work Request to Western's Operations staff for coordination and authorization.
4. CUSTOMER or FIRE FLOW TEST COMPANY coordinates the test date and time with Operations staff.
5. After the test is performed WMWD Operations staff will forward results back to Development Services staff to prepare fire flow test letter.
6. CUSTOMER to specify if they will pick up the letter or have it mailed to them.

PLEASE NOTE: Please allow 2-4 weeks to have fire flow model completed with results or 14 business days to have a fire flow test completed with results.
