SECOND AMENDMENT TO AGREEMENT REGARDING ADDITIONAL
EXTRACTIONS FROM THE SAN BERNARDINO BASIN AREA

This Second Amendment to Agreement Regarding Additional
Extractions From The San Bernardino Basin Area is entered into
between the San Bernardino Valley Municipal Water District,
hereinafter called "VALLEY DISTRICT," and Western Municipal Water
District of Riverside County, hereinafter called "WESTERN."

R E C I T A L S

On December 22, 1981, the parties hereto entered into an
Agreement providing for additional extractions from the San
Bernardino Basin Area by or on behalf of the City of Riverside
upon the terms and conditions specified therein. Paragraph 3 of
said Agreement provides that it may be amended with mutual
consent of the parties in writing, and the parties desire to
amend the said Agreement to provide for increased extractions for
the calendar year 1987 only.

A G R E E M E N T S

NOW THEREFORE, IT IS AGREED by and between the parties hereto
as follows:

1 1. Additional Extractions by City of Riverside.

2 Pursuant to the provisions of Paragraph 8 of the
3 Agreement Regarding Additional Extractions from the San
4 Bernardino Basin Area dated December 22, 1981, entered into by
5 the parties hereto, the limitation upon the annual quantity of
6 additional extractions by or on behalf of the City of Riverside
7 appearing in Paragraph 2 thereof, in the amount of 10,000 acre-
8 feet, is hereby increased to 15,000 acre-feet for the calendar
9 year 1987 only.

10 2. Entities Other Than Plaintiffs.

11 Any production during the calendar year 1987 which will
12 cause extractions from the San Bernardino Basin Area for use by
13 entities other than plaintiffs under the Western Judgment within
14 San Bernardino County to exceed the annual amount of 167,238
15 acre-feet which can be produced without any replenishment
16 obligation shall be counted as temporary additional water rather
17 than production for which replenishment is required under
18 Paragraph VI(c) of the Western Judgment. The replenishment
19 obligations provided in Paragraph X of the Western Judgment shall
20 not apply to the use of additional water, irrespective of its
21 place of use, provided that no water may be exported from the
22 Santa Ana River Watershed.
